# 2. AGE LIMIT (Age as on 01.07.2025) :-

The candidate must have attained the age of 18 years and must not have attained the age of 30 years as on 01.07.2025 i.e must have been born not earlier than 02<sup>nd</sup> July 1995 and not later than 01.07.2025.

Note:- (i). The date of birth of candidates should be between the dates given above table (both days inclusive).

- (ii). The candidate should also note that, once a Date of Birth has been claimed by them and entered in the records of the Administration for the purpose of admission to the examination, no change will be allowed subsequently on any grounds whatsoever.
- (iii) 10<sup>th</sup>/Matriculation Certificate/Equivalent Educational Certificate/Educational Certificate mentioning date of Birth is mandatory for D.O.B (Date of Birth) otherwise application will be rejected.

## 2.2 **EXTENT OF AGE RELAXATION**

- 2.2.3 <u>Staff of Quasi Administrative Offices of Railway Organisations</u>: Relaxation of age will be to the extent of 5 years (or) service rendered by them in such organizations, whichever is less.
- 2.2.4 **Ex-SERVICEMEN CANDIDATES**: Relaxation of age will be up to the extent of service rendered by them in Defense Services plus 3 years provided they have put in a minimum of 6 months service after attestation.

#### 3.1 **FEE EXEMPTIONS:**

Candidates belonging to SC/ST/EXSM, persons with disabilities, Women Candidates, Minority candidates and candidates belonging to Economically Backward Classes are exempted from payment of examination fees.

## Note:-

- Minorities will mean Muslims, Christians, Sikhs, Buddhists and Zoroastrians (Parsis).
- Economically Backward Classes will mean the candidates whose family income is less than Rs. 50,000/- per annum.
- Authorities competent to issue income certificates for the purpose of identifying Economically Backward Classes.
- District Magistrate or any other Revenue Officer up to the level of Tehsildar.
- Sitting Member of Parliament of Lok Sabha for persons of their own constituency.
- iii. Below Poverty Line (BPL) Card or any other certificate issued by Central Government under recognized poverty alleviation programme of izzat MST issued by Railways.
- Union Minister- may also recommend for any persons from anywhere in the country.
- Sitting Member of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside.

#### 5 SELECTION PROCESS & FORMATION OF PANEL

The selection against Cultural quota will comprise written test (Objective type question) & Practical demonstration. Candidates should attach there supporting documents for the same. The candidate who apply in response to this notification issued and are found eligible for consideration for appointment against cultural quota should be assessed on the basis of:

- Written test :- 50 marks (Note: The written test will consist of objective type questions.) (Candidates five times of vacancy will be called for practical demonstration, subject to minimum passing masks)

## 6. SYLLABUS

The syllabus of written test will be based upon the educational qualification and Degree/Diploma/Certificates. Proficiency in instruments playing/Classical Dancer to be assessed during Practical Examination. Candidate should attach supporting documents for the same.

## 7. HOW TO APPLY

- 1. Application in prescribed format on A-4 size good quality paper may be down loaded from the website www.rcf.indianrailways.gov.in may be typed neat & clean one side.
- Application is to be filled up by the candidate himself in his/her own handwriting and must signed affixing a passport size photograph with clear face on the space provided and one should be attached duly attested.
- Applicant will attach the attested photocopies of Educational and Cultural achievement certificates. SC/ST/OBC/EBC candidates should also attach the attested copy of caste certificate on proper format.
- 4. Candidates to ensure their eligibility before applying: The candidates should ensure that they fulfill all eligibility conditions prescribed for the post. Eligibility of the candidates for the post notified in this notification would be decided on the basis of the information furnished by them. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her application is false/incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria for the post(s), his/her candidature will be cancelled forthwith.
- 5. Railway Administration will not be responsible for late delivery and postal delay.
- 6. The last date & time for receipt of application in the office of the General Manager (Personnel) Recruitment Cell, Rail Coach Factory, Kapurthala-144602 is dated 22.02.2025 up to 17.00 hrs.
- 7. Candidate super scribe clearly on the Envelope "RECRUITMENT AGAINST CULTURAL OUOTA FOR THE YEAR 2024-25.
- 8. The application should sent by any posts i.e. Ordinary post, registered post/Courier/by Registered AD will be accepted.
- 9. Railway Administration reserves the right to cancel the Recruitment process in exceptional circumstances.
- 10. Under no circumstances applications received after the closing date & time will be entertained.
- 11. Candidates recruited against cultural quota through open advertisement shall be terminated from service, if the information and documents furnished by them for recruitment, are found incorrect/fake at any stage; observing requisite procedure for such termination.
- 12. Candidates those who are already in service of PSU/Govt Organizations and are eligible for the above should produce 'No Objection Certificate' for the same from their employer at the time of applying /trials.
- 13. Candidate's admission at all stages of the recruitment will be purely provisional subject to satisfying the prescribed eligibility conditions. Mere issue of call letters to the candidate will not imply that his his/her candidature has been finally cleared.
- 14. The candidate having cultural norms for higher level and apply against the vacancies for the lower level can be considered. However, he/she will not claim for higher level after joining the Railways on the basis of Cultural achievements prior to joining Railways.
- 15. The decision of selection committee/administration in all matters relating to eligibility, acceptance or rejection of application etc. will be final and binding on the candidates and no inquiry or correspondence will be entertained in this connection.
- 16. Production of original documents of Date of birth, Educational Qualification, Possession Degree/Diploma/ Certificate in respective discipline only from Government recognized Institute Achievement and SC/ST/OBC/EWS etc on the day of Trial and Interview is

mandatory without which they will not be allowed to appear in the Trial/Interview. Certificates in languages other than English or Hindi should be accompanied by an attested translation in English/Hindi. No TA/DA/Accommodation will be given for appearing in the selection trials/interview. Applicants will have to bring their own kit. They may also be required to stay during the selection trials for 2-3 days, for which they have to make their own arrangements. The railway administration has all rights reserved to fix any date/place or postpone trials/interview or cancel due to unforeseen causes against which no claim will be accepted.

## 9. Invalid Applications/Rejections:-

Applications with the following short coming will be rejected:-

- (i) The Candidate who will apply more than one post, his/her application will be rejected.
- (ii) Not Possessing the prescribed Educational/Technical/ and Professional (Cultural) Qualification for the post on the date of submission of application.
- (iii) Relevant certificates as proof for claiming age relaxation or fee relaxation if any wherever claimed.
- (iv) Application without proof of age.
- (v) Applications over-aged or under-aged candidates and also where date of birth certificates attached are illegible, date of not filled in or wrongly filled.
- (vi) Incorrect/Incomplete applications in any form, is liable to be rejected.
- (vii) Multiple Applications with minor changes of information and/or facts of varied details of same post.
